The band collectively hereby assigns the **Publishing, Intellectual and Mechanical Rights** to their song / composition that has been shared with iRock on the website <https://www.independencerock.in/mumbaimirrorbandhunt> to iRock for a period of **1 year** starting from the date of acceptance of the Terms & Conditions document.

The band also warrants that the submitted compositions lyrics & music have been composed by the band in particular and no part of the lyric OR music has been taken from any other composition and no other artiste / musicians intellectual / publishing rights have been infringed upon by the band.

The band also undertakes to indemnify iRock in case of any legal action / suit arising from any or all acts of infringement by the band of Any Copyright & Intellectual Property Rights of any other musician / composer whose rights our track OR composition might have infringed upon.

iRock will have exclusive, irrevocable, perpetual, royalty-free, unconditional rights to publish and use our audio and video links (including still pictures) that the band submits as a part of our Independence Rock registration.
